REPORTS

ANNUAL PRESBYTERY BOARD REPORT

The Presbytery of the Wolverine Association met Nov. 18, 1954, at Niles, Mich., for the purpose of organizing a church and the ordination of a minister. In the absence of the Chairman, Rev. Charles Thigpen, Rev. Mark Lewis served as Moderator along with Rev. Johnnie Floyd and a proxy, Rev. J. A. Fredericks, representing the Presbytery.

The service was begun by singing "Love Lifted Me" and prayer by Bro. Walters, preceding an introduction of the Presbytery Board by Rev. Mark Lewis.

A message giving a challenge to the prospective church was delivered by Rev. Johnnie Floyd, the subject being, "What Are You Building For, Time Or Eternity?" (Col. 3:12-24).

Rev. Lewis then proceeded to organize the church after reading Matt. 16:13-18. He also read Chapter I, Section I of the Treatise of F.W.B. for the purpose of directing questions concerning the interested group to the prospective pastor, Rev. W. D. Jaggers. The information was as follows: Length of work, three Sundays—Rev. W. D. Jaggers and Bro. Charles Morgan, former of Benton Harbor, Mich., and latter of Little Rock, Ark., were beginners of the new work: Aver. Att. S.S.—26; Aver. Ch. Att.—44: Good testimony given of church members' characters by Bros. Jaggers and Morgan: Four conversions to present time: Hall rented by month at \$45.00 per month: Will start building fund immediately upon organization: F.W.B. doctrine accepted: No eternal security belief in midst: Open communion accepted: Will join Wolverine Association and back it.

Motion made by Rev. J. A. Fredericks, seconded by Rev. Johnnie Floyd, member and proxy of Presbytery Board, to organize the group into a F.W.B. Church.

Rev. Lewis gave Bible in charge form to Rev. Jaggers, who represented the church. Church Covenant was read and adopted by church group, who then presented themselves for charter membership, ten in number. Rev. Lewis entertained a motion that they be accepted and it was agreed that Church Charter stay open for thirty days.

Rev. Floyd made a move, seconded by Rev. Fredericks, that the Presbytery accept the action as official. A prayer of consecration was led by Rev. Lewis and Jaggers. Rev. Lewis declared the First Free Will Baptist Church of Niles, Mich. in order and the membership then proceeded to elect the officers of the body.

Charter Members: William O. Grant, Charles W. Morgan, John W. Morgan, Mrs. Nellie Ruth Morgan, Clayton Grant, Mrs. Jewel Draper, Mrs. Catherine Morgan, Mrs. Dell Grant, Miss Ozella Morgan, Miss Mary Myers.

Bro. Charles Morgan nominated Bro. William O. Grant for clerk and treasurer. Rev. Lewis moved nominations cease and proceed to elect by acclamation. The Church approved.

Bro. William Grant nominated W. D. Jaggers as Pastor. Bro. Charles Morgan moved nominations cease and proceed to elect by acclamation. The Church approved.

Since there was no deacon material at the present time, Rev. Lewis, Moderator, advised two trustees be elected. Bro. William O. Grant nominated Charles Morgan. Bro. Charles Morgan nominated John Morgan. The Church approved.

The Presbytery Board approved the action; Rev. Fredericks moved, seconded by Rev. Floyd, that the church with officers be acclaimed as set in order officially. Business was adjourned and song, "Amazing Grace", was sung.

PRESBYTERY LEADS ORDINATION SERVICE

Moderator, Rev. Lewis called Rev. W. D. Jaggers and wife forward for the ordination. Rev. Jaggers testified of his call to the ministry: a Christian four years, need of work felt, received license given June, 1953, issued by Wolverine Association, twenty questions answered and passed on by Presbytery Board, license carried for one year, questions for ordination answered and passed on by Presbytery Board.

Rev. Lewis gave the Charge Message to Rev. Jaggers and wife. The Charge was accepted by them before the council, the people and God.

The Bible, as the Word of God, was presented by Rev. Floyd to Rev. Jaggers and wife.

The final moments of ordination by laying on of hands and prayer were carried out by the Presbytery, Rev. Lewis, Rev. Floyd and the proxy for Bro. Thigpen, Rev. Fredericks. Adjournment followed and the work was finished for the Lord in Niles, Mich.

Presbytery meeting, Philadelphia F.W.B. Church, Dec. 2, 3 & 4, 1954. Rev. Mark Lewis was elected Chairman of the Presbytery, Rev. Charles Thigpen was elected Vice-Chairman. Rev. Johnnie Floyd was elected Secretary and Clerk.

- 3. Go to the Flint Friendship Church at a called, appointed time and ordain Arnold Clark as a deacon.
- 4. Further question and ordain Ward Wilson of the West Wayne F.W.B. hurch at a called, appointed time, for the ministry.
- 5. Send ordination questions to Jessie White, soon to be ordained as requested in petitionary letter to the Presbytery at the time set soon after Christmas of 1954.
- 6. Send Minister's card to W. D. Jaggers of Niles, Mich. He was recently ordained by the Presbytery.
- 7. Mr. White and Mr. Hogan of the West Wayne Church were thoroughly questioned by the Presbytery on this meeting. A date at an appointed, called time around the first of 1955 to be given for their ordination at said church.
- 8. Relicense John Edwards for the ministry. He is from the First Church of Flint.
- 9. Presbytery sanctions quartette from College in Nashville to come on an itinerate singing mission to Michigan upon the approval of the individual pastors.
- 10. Make investigation and ask surrender of credentials from George Ritter. Send request letter by registered mail for desired time of meeting. Send self-addressed envelope for return answer.
- 11. Mail deaconship papers to Myron Van Nada of Burton Church, Flint.

Charles Thigpen. Ordination prayer led by Bro. Thigpen. Bro. White was welcomed into fellowship, followed by a song. Presentation of certificate by Rev. Johnnie Floyd. Bro. White gave his testimony. Benediction was pronounced by Bro. Tancel Orr.

Meeting of Jan. 9, 1955, 3:00 P.M., at River Rouge F.W.B. Church.

CONSTITUTION

PREAMBLE

The object and purpose of this organization shall be to unify and strengthen the work of the various churches composing the Wolverine Association of Free Will Baptists and to devise and execute measures for the extension of the Kingdom of God in connection with the various churches in the Association or that may be hereafter represented therein.

ARTICLE I

NAME—This organization shall be known as the Wolverine Association of Free Will Baptists of Michigan.

ARTICLE II

COMPOSITION—The Wolverine Association shall be composed of its general officers, the members of all boards or committees, and duly appointed delegates chosen by the churches belonging to said Association.

ARTICLE III

REPRESENTATION—Representation in the Wolverine Association is to be by churches which are affiliated with this body. Each church shall be entitled to six delegates elected from the laity, all ordained

ministers, deacons, licensed preachers, pastor's wife, church clerk, general Sunday School superintendent, general league director and president of Woman's Auxiliary, providing the delegates are members in good standing of the local church they represent.

ARTICLE IV

Section 1. OFFICERS—The officers of this Association shall consist of a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, a Treasurer and a Promotional Secretary, each of whom shall be elected at the close of each annual session.

Section 2. BOARDS—The Boards of the Wolverine Association shall be the following: Board of Finance, Presbytery Board, Home Mission Board, Board of Education, Superannuation Board, and Sunday School and League Board. The personnel of each of the foregone shall be elected as follows: the first named for a term of one year, the second for a term of two years, the third for a term of three years, the fourth for a term of four years, and the fifth for a term of five years. Succession to office thereafter shall be for a period of five years.

Section 3. COMMITTEES—Committees, as necessary, shall be appointed by the Moderator unless otherwise provided for, and shall hold office until their work is completed or until their successors are elected.

ARTICLE V

EXECUTIVE BOARD—The Executive Board shall consist of the Moderator, Clerk and Treasurer of the Wolverine Association and the Chairman of each of the Boards of the Wolverine Association. The Promotional Secretary shall be an Ex-officio member of the Executive Board.

ARTICLE VI

FINANCE—We recommend that each church pay ten per cent (10%) of its regular income into the treasury of the Association to be used in the various phases of the denominational work at the discretion of the Association. (Compliance with this recommendation is not compulsory for affiliation, but the plan has proven successful in financing our work.)

ARTICLE VII

Section 1. DISCIPLINE—This Association shall have power to act only as an advisory counsel to give churches advice in matters of difficulty; to enquire into the way churches neglect to represent in this Association; to invite brethren in the ministry to a seat in the Association; to exclude from the body any member who does not conform to the Rules of Decorum and shall report their conduct to the church from which they were sent.

Section 2. All matters involving disciplinary matters shall be handled according to the Treatise of the National Association of Free Will Baptists.

ARTICLE VIII

MEETINGS—The meetings of the Wolverine Association shall be held each quarter and shall begin on Thursday night before the first Sunday in June, September, December and March. The meeting beginning before the first Sunday in June shall be called the Annual Meeting.

ARTICLE IX

WOMAN'S AUXILIARY—The District Woman's Auxiliary Convention shall be recognized as a subordinate organization to the Wolverine Association. It shall organize at its own discretion and have power to create and adopt a Constitution and By-Laws, and maintain complete management of the work for which it is constituted. An annual report shall be submitted to the Wolverine Association.

ARTICLE X

This Constitution may be amended or altered at any regular Annual session of the Wolverine Association by a two-thirds vote of the members present, provided proposed amendment or alteration be presented to the body in writing one day in advance.

BY-LAWS

- 1. The Moderator and the Treasurer shall receive an honorarium of \$50.00 each annually, for their services. The Clerk shall receive \$100.00 annually.
- 2. The Standing Boards shall be composed of five (5) members each and may be elected either from the ordained authority or the laity, except the Presbytery. The Presbytery shall consist of ordained authority, two of which may be Deacons. The members of Standing Boards shall be elected for a term of five (5) years, with their term of office to expire alternately.
- 3. The duties of the various Standing Boards shall be to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary and as may be found in harmony with the principles and tenets of the Wolverine Association. Each Board shall draft By-Laws to govern their work. These By-Laws shall be subject to the approval of the Wolverine Association.
- 4. Any duly ordained minister or deacon, who is in good standing with this body has the privilege of sitting in council with the Presbytery at any time, but will not be permitted to vote unless he is appointed to serve by proxy, by an absentee member or selected by a majority present.
- 5. The purpose of the Presbytery shall be for the mutual improvement of the ministry, their protection against hostile influences, for the maintaining of a clean and pure character among those of the ordained authority. It shall also become the duty of the Presbytery to examine all candidates for license to preach the Gospel or to ordain the same at the request of the local church.
- 6. Before granting a license or endorsing credentials of any minister from another denomination to preach the Gospel, the candidate must have been a member of a church in this Association at least six (6) months.
- 7. The local church must first request by letter the licensing or ordaining of all candidates before the Presbytery can act.
- 8. Before license or ordination, the candidate is examined as to his gifts, personal piety and doctrines, his call to the ministry, his adaptability and devotion to the work, his reputation, character, ability, and his present and prospective educational and professional qualifications. A list of questions should be prepared by the Presbytery and the candidate should be required to make a grade of not less than 70% before license is granted. The examination for ordination should include all that is required for license, and also satisfactory examination respecting the life and labors of the candidate and his attainments, at least in the departments of English education, doctrinal and pastoral theology, and homiletics.
- 9. The examination of deacons shall be according to I Timothy, Chapter 3.

- 10. A minister shall be licensed for a period of one year, after which his local church may request another examination and the Presbytery shall decide whether or not the license be extended or the candidate be ordained. If an offense is made during the year, and the candidate repents, the license will be forfeited and he will be forced to begin anew.
- 11. A minister from another denomination wishing to unite with this Association must first make application to a church which requests action of the Presbytery the same as for license or ordination.
- 12. Be it known that any minister or deacon coming under the hands of the Presbytery who walks disorderly, or commits an offense must come before this body and make restitution or willingly give up such rights of license or ordination papers or card by this body, or they agree to be published in any or all newspapers as this body deems necessary.
- 13. An annual written report of the activities of every board shall be made by the secretary of each board to the Association, or as often as is necessary.
- 14. All ministers of this Association are required to report in person or letter to the Annual Association with a written report of their work. Failure to report to the Association at least once a year will forfeit the minister's standing and he will be dropped from the Association.
- 15. The Constitution and By-Laws are to be printed in Minutes at all times.
- 16. For further information pertaining to the officers of the local church and their duties, the church should consult the Treatise of the National Association of Free Will Baptists, Chapter I, under "The Church".
- 17. These By-Laws may be amended at any regular session of the Wolverine Association by a two-thirds vote of the members present and voting.

DOCTRINE

- 1. GOD. We believe in one true and living triune God; composed of the Father, Son and Holy Spirit, equal in divine essence, purpose, power and glory. St. John 1:1; I Cor. 8:6; St. John 10:30.
- 2. CHRIST. We believe that Jesus Christ is the divine Son of God, was with the Father and the Holy Spirit at the time of Creation, left the courts of Heaven and came to this earth: took upon Himself the form of humanity, manifested His power, was crucified, placed in Joseph's tomb, rose from the dead the third day, completed the great plan of salvation, walked and talked with His disciples, publicly ascended up to Heaven, and that He will descend again to gather His jewels home. Isa. 9.6; St. John 1:14; Luke 1:26-28; 24:50-53; Acts 1:9-12; Mark 16:9-19; 15:22-47.
- 3. HOLY SPIRIT. We believe that the Holy Spirit has visited true believers in all ages, and especially since the ascension of the Son back to the Father and His coming on the day of Pentecost, has taken up His office work among all nations of people as a Divine Reprover, Comforter and Guide. Judges 6:34; 11:29; St. John 16:8-14; Isa. 63:10-12; Eph. 4:30; Acts 8:17-20; Ezek. 36:27; Joel 2:28.
- 4. THE BIBLE. We believe the Bible, which is composed of the Scriptures of the Old and New Testaments, was given by the inspiration

of God, is our way-bill from earth to Heaven, and the only infallible rule of faith and practice. II Pet. 1:19-21; II Tim. 3:14-17; Daniel 10:21; Acts 1:16-17; Matt. 21:42.

- 5. THE FALL OF MAN. We believe that God created man good, gave him a just law by which he should be governed with promise of reward for faithfulness and with penalties of punishment for disobedience, gave man free moral agency to choose the right and reject the wrong. But our first parents heeded the voice of the great enemy of souls, voluntarily transgressed the law of God, fell with their posterity under the just penalty of the same, and were unable of their own power to extricate or save themselves from the great dilemma into which they had fallen. God gave them the hope of salvation through the coming CHRIST. Gen. 1:27; 2:16-17; Psalms 51:5; Gen. 3; Rom. 5:12-19; John 3:6; Eph. 2:3.
- 6. REDEMPTION, SALVATION, ADOPTION. We believe Jesus Christ by His birth, death, burial, resurrection and ascension paid the purchase price for all who come upon Gospel terms, a law of adoption into the Kingdom of Heaven, and of eternal inheritance into the glorified kingdom above. Heb. 9:12; Gal. 3:13; 4:4-5; Titus 2:14; Heb. 1:4; St. John 3:16, Isa. 15:22.
- 7. CONDITION OF SALVATION. We believe that all persons dying in infancy and all idiots are saved by the atoning merits of the Son of God without an act on their part; that persons coming to the years of accountability, transgressing the law of God, must upon their part exercise faith in Jesus Christ through repentence toward God, at the completion of which, pardon takes place in the mind of the Father and by the Holy Spirit, they pass through the ordeal of regeneration, are washed in the blood of the Lamb, and are planted in the Kingdom of Christ. John 3; 4:11-16; Matt. 19; 13-22; I Cor., 7:10; Luke 18:16-17; Psalms 98:3.
- 8. SALVATION FREE. We believe that God desires the salavation of all, Christ died for all, the Gospel invites all, and whosoever will may come and be saved upon the terms of the Gospel. I Pet. 1:9-25; 2:9-25; Rev. 22:17.
- 9. BAPTISM. We believe that Christian baptism is the immersion of believers in water in the name of the Father, Son and the Holy Spirit, in which are represented the burial and resurrection of Christ; also represents our death to sin and only those who have come under the Presbytery of the Elders are qualified to administer the same. Matt. 3:14-16; 3:5-6; I Pet. 3:21; St. John 3:23; Acts 10:47; Matt. 28:19.
- 10. COMMUNION AND FEET WASHING. We believe that the Lord's Supper and the washing of the saint's feet are ordinances of the Gospel of Christ; the Lord's Supper was instituted by our Saviour to commemorate His broken body and shed blood for the sins of the world, and to show our remembrance of Him till He comes. All Christians have a right to the Lord's Supper and should be invited: "Let a man examine himself and so let him eat."

The washing of feet was instituted by our Lord at the same time that the Supper was instituted as an act of humility to show our love for each other, and both ordinances should be perpetuated by all Christians until His second coming. Luke 22:18, 20; I Cor. 11:20-29; St. John 13:1-17; Matt. 26:26-29.

11. SABBATH. We believe that the Christian Sabbath should be observed as a day of rest and for the worship of God, that we should

abstain from all sinful amusements and secular employments, works of mercy and piety excepted. Ex. 20:11; 31:12-18; Deut. 5:12-15; Ezek. 20:12; Matt. 28:1; Luke 23:56; Acts 13:12-18; Mark 2:27.

- 12. CALL TO THE MINISTRY. We believe in divine call to the ministry, that God in His goodness and power of grace, impresses His ministers with the burden of lost souls to the extent that the call becomes irresistible to personal contentment, that when they yield to the call and exercise the native gifts according to the Scriptures, with a full reliance upon Him, He accompanies them in the person of the Holy Spirit, to guide them in the way of truth and to bless their labors according to His purpose. Jonah 1:1; Jer. 1:5; Mark 3:14; Acts 1:22-26; Matt. 28:19.
- 13. THE VISIBLE CHURCH. We believe that a visible church of Christ is a congregation of faithful men and women having obtained fellowship with the Lord and each other, agreeing to keep up a good discipline and doctrine according to the rules of the Gospel. II Thess. 1:1; Acts 16:5; III John 1:19; Matt. 18:17; Acts 20:28; Rev. 1:4-20.
- 14. PERSEVERANCE. We believe that all true believers in Christ should persevere in divine grace and in the knowledge of the truth and that God's grace is sufficient to help them overcome all the obstacles of life and that all the combined forces of the great enemy of souls on earth and in hell (or in his eternal abode) are not able to pluck them from His hand so long as they walk in the path of duty; but those who sidestep and willfully refuse or neglect to perform their duty, they would backslide; if persistantly continued, would be eternally lost. II Pet. 1:12; II Cor. 9:10; II Pet. 1:4-8; 2:2; Rom. 8:35-39; Apostacy: II Pet. 18-9; I Cor. 10:1-13; Heb. 12:15-17; I John 5:16; Heb. 6:1-6; I Tim. 4:1-2; Heb. 3:12; St. John 15:1-7; Matt. 12:31-32.
- 16. CHRIST, THE HEAD OF THE CHURCH. We believe that Christ is the head of the Church and that the government of the local church is with the body. Col. 1:18-19; Matt. 16:18; Heb. 12:23; Matt. 21:42; Eph. 1:22; Acts 16:4-5.
- 17. SANCTIFICATION. Sanctification is the work of God's grace by which the soul is cleansed from all sin and wholly consecrated to Christ. It takes place in regeneration and the Christian can and should abide in this state to the end of life, constantly growing in the grace and the knowledge of our Lord Jesus Christ. I Cor. 6:11; II Thess. 2:13; Heb. 12:14; Phil. 3:21; II Thess. 5:19-23; St. John 17:17-19; II Tim. 2:20-21.
- 18. THE RESURRECTION. We believe in the resurrection of the dead, both the righteous and the wicked. When the resurrection shall take place, the soul and body shall be united, the righteous shall be received into everlasting happiness to reign with God forever; but the wicked shall go away into everlasting punishment. Matt. 28:6; John 5:28-29; I Cor. 15:51-58.
- 19. THE SOUL. The soul is endless, hence does not die with the body, but immediately after death, enters into a conscious state of happiness or misery, according to the spiritual character here possessed. Phil. 1:23; Luke 23:48; Rev. 6:9; Luke 16:19-25; Matt. 10:28.
- 20. JUDGMENT. We believe that there will be a general, universal judgment, when all men shall be judged according to their works, whether they be good or bad, and that immediately thereafter, the wicked shall enter into everlasting punishment and the righteous into everlasting happiness. II Thess. 1:4-9; Rev. 14:9-13; Luke 16:23; Rev. 21:8; II Cor. 5:10; Matt. 12:36; Rev. 20:12-13; Acts 17:31.

RULES OF DECORUM

- 1. The Association, when convened, shall be opened and closed by singing and prayer.
- 2. Only one person shall speak at a time, who shall arise to his feet and address the Moderator.
- 3. Each person thus speaking shall not be interrupted in speech, except by the Moderator, until he gets through; nor shall the Moderator interrupt him unless he breaks order.
- 4. The person speaking shall adhere to the question and shall in no wise cast reflections on any person who may have spoken before him.
- 5. No person shall speak more than three times on the same subject without leave of the Association.
 - 6. No person shall laugh or whisper in time of public speech.
- 7. Members shall address each other by the appellation of Brother or Brethren and Sisters.
- 8. No member of this Association shall absent himself when the Association is sitting in conference without leave of the Moderator.
- 9. The names of the members of this Association shall be enrolled and called over as often as the Association thinks it necessary.
- 10. No member shall speak longer than fifteen minutes at any time without leave of the Moderator.

CHURCH COVENANT

Having given ourselves to God by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearances of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages and to "provide things honest in the sight of all men".

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions and social worship: and by self-denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ".

We will not forsake the assembling of ourselves together for church conferences, public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation and seek to strengthen the weak, encourage the afflicted, admonish the erring and, so far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday Schools and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.
