A motion was carried to adjourn this business session and a closing prayer was offered by Rev. Hollifield.

Bro. Willis gave the Conference some pertinent information concerning the National Home Mission work.

Rev. Charles Thigpen presented the program for the coming Michigan State Association.

The benediction was pronounced by Rev. Erwin Sells.

SATURDAY MORNING BUSINESS SESSION

The report of the Home Mission Board was read by Rev. William Newsome. A motion was carried to receive the report.

The Board of Finance report was read by Rev. William Newsome. A motion was carried to adopt the report and the recommendations contained therein.

The report of the Temporary Business Committee was read by Rev. Gene Anderson. A motion was carried to adopt this report which contained four recommendations, in it's entirety. A standing vote was taken.

The report of the Obituary Committee was called for. A motion was carried to receive the report. The body stood in a moment of silent meditation in memory of these loved ones and then were led in audible prayer by Sis. Blanche Maynard.

The report of the Constitution Revision Committee was read by Rev. Charles Thigpen. This report contained two recommendations and a motion was carried to adopt same as read.

Two additional ministerial reports were received and read. A motion was carried to receive these reports and to grant these men their annual ministerial certificates.

February 28th to June 1st, 1957

Your Promotional Secretary is happy to greet you in this the second Annual Meeting of the Wolverine Association since this office was created. God has, and is yet, adding His blessing to our work here in this great field. The work of the Promotional Office has been some different during this quarter to others. Still, it has been a blessing to serve you in this capacity. My time for service in the office has been quite limited, but the blessing has been full.

Services Conducted or Preached in:

CONSTITUTION

PREAMBLE

The object and purpose of this organization shall be to unify and strengthen the work of the various churches composing the Wolverine Association of Free Will Baptists and to devise and execute measures for the extension of the Kingdom of God in connection with the various churches in the Association or that may be hereafter represented therein.

ARTICLE I

tion of Free Will Baptists of Michigan.

ARTICLE II

COMPOSITION—The Wolverine Association shall be composed of its general officers, the members of all boards or committees, and duly appointed delegates chosen by the churches belonging to said Association.

ARTICLE III

REPRESENTATION—Representation in the Wolverine Association is to be by churches which are affiliated with this body. Each church shall be entitled to six delegates elected from the laity, all ordained ministers, deacons, licensed preachers, pastor's wife, church clerk, General Sunday School Superintendent, General League Director and president of Woman's Auxiliary, providing the delegates are members in good standing of the local church they represent.

ARTICLE IV

Section 1. OFFICERS—The officers of this Association shall consist of a Moderator, Assistant Moderator, a Clerk, an Assistant Clerk, a Treasurer and a Promotional Secretary, each of whom shall be elected at the close of each annual session.

Section 2. BOARDS—The Boards of the Wolverine Association shall be the following: Board of Finance, Presbytery Board, Home Mission Board, Board of Education, Superannuation Board, and Sunday School and League Board. The personnel of each of the foregone shall be elected as follows: the first named for a term of one year, the second for a term of two years, the third for a term of three years, the fourth for a term of four years, and the fifth for a term of five years. Succession to office thereafter shall be for a period of five years.

Section 3. COMMITTEES—Committees as necessary shall be appointed by the Moderator unless otherwise provided for, and shall hold office until their work is completed or until their successors are elected.

ARTICLE V

EXECUTIVE BOARD-The Executive Board shall consist of the Moderator, Clerk, and Treasurer of the Wolverine Association, and the Chairman of each of the Boards of the Wolverine Association. The Promotional Secretary shall be an Ex-officio member of the Executive Board.

ARTICLE VI

FINANCE—We recommend that each church pay ten per cent (10%)of its regular income into the treasury of the Association to be used in the various phases of the denominational work at the discretion of the Association. (Compliance with this recommendation is not compulsory for affiliation, but the plan has proven successful in financing our work.)

ARTICLE VII

Section 1. DISCIPLINE—This Association shall have power to act only as an advisory counsel to give churches advice in matters of difficulty;

to enquire into the way churches neglect to represent in this Association; to invite brethren in the ministry to a seat in the Association; to exclude from the body any member who does not conform to the Rules of Decorum and shall report their conduct to the church from which they were sent.

Section 2. All matters involving disciplinary matters shall be handled according to the Treatise of the National Association of Free Will Baptists.

ARTICLE VIII

MEETINGS—The meetings of the Wolverine Association shall be held each quarter and shall begin on Thursday night before the first Sunday in June, September, December and March. The meeting beginning before the first Sunday in June shall be called the Annual Meeting.

ARTICLE IX

WOMAN'S AUXILIARY—The District Woman's Auxiliary Convention shall be recognized as a subordinate organization to the Wolverine Association. It shall organize at its own discretion and have power to create and adopt a Constitution and By-Laws, and maintain complete management of the work for which it is constituted. An annual report shall be submitted to the Wolverine Association.

ARTICLE X

This Constitution may be amended or altered at any regular Annual Session of the Wolverine Association by a two-thirds vote of the members present, provided proposed amendment or alteration be presented to the body in writing one day in advance.

BY-LAWS

- 1. The Moderator and the Treasurer shall receive an honorarium of \$50.00 each annually, for their services. The Clerk shall receive \$100.00 annually.
- 2. The Standing Boards shall be composed of five (5) members each and may be elected either from the ordained authority or the laity, except the Presbytery. The Presbytery shall consist of ordained authority, two of which may be Deacons. The members of Standing Boards shall be elected for a term of five (5) years, with their term of office to expire alternately.
- 3. The duties of the various Standing Boards shall be to plan a program and supervise its operation in their respective fields. They shall organize themselves and regulate their work as may become necessary and as may be found in harmony with the principles and tenets of the Wolverine Association. Each Board shall draft By-Laws to govern their work. These By-Laws shall be subject to the approval of the Wolverine Association.
- 4. Any duly ordained minister or deacon, who is in good standing with this body has the privilege of sitting in council with the Presbytery at any time, but will not be permitted to vote unless he is appointed to serve by proxy by an absentee member, or selected by a majority present.
- 5. The purpose of the Presbytery shall be for the mutual improvement of the ministry, their protection against hostile influences, for the maintaining of a clean and pure character among those of the ordained authority. It shall also become the duty of the Presbytery to examine all candidates for license to preach the Gospel or to ordain the same at the request of the local church.

- 6. Before granting a license or endorsing credentials of any minister from another denomination to preach the Gospel, the candidate must have been a member of a church in this Association at least six (6) months.
- 7. The local church must first request by letter the licensing or ordaining of all candidates before the Presbytery can act.
- 8. Before license or ordination, the candidate is examined as to his gifts, personal piety and doctrines, his call to the ministry, his adaptability and devotion to the work, his reputation, character, ability, and his present and prospective educational and professional qualifications. A list of questions should be prepared by the Presbytery and the candidate should be required to make a grade of not less than 70% before license is granted. The examination for ordination should include all that is required for license, and also satisfactory examination respecting the life and labors of the candidate and his attainments, at least in the departments of English education, doctrinal and pastoral theology, and homiletics.
- 9. The examination of deacons shall be according to I Timothy, Chapter 3.
- 10. A minister shall be licensed for a period of one year, after which his local church may request another examination and the Presbytery shall decide whether or not the license be extended or the candidate be ordained. If an offense is made during the year, and the candidate repents, the license will be forfeited and he will be forced to begin anew.
- 11. A minister from another denomination wishing to unite with this Association must first make application to a church which requests

action of the Presbytery the same as for license or ordination.

- 12. Be it known that any minister or deacon coming under the hands of the Presbytery who walks disorderly, or commits an offense must come before this body and make restitution or willingly give up such rights of license or ordination papers or card by this body, or they agree to be published in any or all newspapers as this body deems necessary.
- 13. An annual written report of the activities of every board shall be made by the secretary of each board to the Association, or as often as is necessary.
- 14. All ministers of this Association are required to report in person or letter to the Annual Association with a written report of their work. Failure to report to the Association at least once a year will forfeit the minister's standing and he will be dropped from the Association.
- 15. The Constitution and By-Laws are to be printed in Minutes at all times.
- 16. For further information pertaining to the officers of the local church and their duties, the church should consult the Treatise of the National Association of Free Will Baptists, Chapter 1, under "The Church."
- 17. These By-Laws may be amended at any regular session of the Wolverine Association by a two-thirds vote of the members present and voting.

ARTICLES OF FAITH

I. THE HOLY SCRIPTURES

These are the Old and the New Testaments: they were written by holy men, inspired by the Holy Spirit, and are God's revealed word to man. They are a sufficient and infallible rule and guide to Salvation and all Christian worship and service.

II. BEING AND ATTRIBUTES OF GOD

The Scriptures teach that there is only one true and living God, who is Spirit, self-existent, eternal, immutable, omnipresent, omniscient, omnipotent, independent, good, wise, holy, just, and merciful, the Creator, Preserver, and Governor of the universe; the Redeemer, Savior, Sanctifier, and Judge of men; and the only proper object of worship.

The mode of His existence, however, is a subject far above the understanding of man—finite beings cannot comprehend Him. There is nothing in the universe that can justly represent Him, for there is none like Him. He is the fountain of all perfection and happiness. He is glorified by the whole creation, and is worthy to be loved and served by all intelligence.

III. DIVINE GOVERNMENT AND PROVIDENCE

1. God exercises a providential care and superintendence over all his creatures, and governs the world in wisdom and mercy, according to the testimony of His Word.

2. God has endowed man with power of free choice, and governs him by moral laws and motives; and this power of free choice is the exact measure of man's responsibility.

3. All events are present with God from everlasting to everlasting; but His knowledge of them does not in any sense cause them, nor does He decree all events which He knows will occur.

IV. CREATION, PRIMITIVE STATE OF MAN AND HIS FALL

SECTION I—CREATION

1. Of The World. God created the world, and all things that it contains, for His own pleasure and glory and the enjoyment of His creatures.

2. Of the Angels. The angels were created by God to glorify Him and obey His commandments. Those who have kept their first estate He employs in ministering blessings to the heirs of salvation and in executing His Judgments upon the world.

3. Of Man. God created man, consisting of a material body and a thinking, rational soul. He was made in the image of God, to glorify his Maker.

SECTION II—PRIMITIVE MAN, AND HIS FALL

.

۰.

Our first parents, in their original state, were upright. They naturally preferred and desired to obey their Creator, and had no preference or desire to transgress His will until they were influenced and inclined by the tempter to disobey God's commands. Previous to this, the only tendency of their nature was to do righteousness. In consequence of the first transgression, the state under which the posterity of Adam came into the world is so different from that of Adam that they have not that righteousness and purity which Adam had before the fall; they are not willing to obey God, but are inclined to evil. Hence none, by virtue of any natural goodness and mere work of their own, can become the children of God; but they are all dependent for salvation upon the redemption effected through the blood of Christ, and upon being created anew unto obedience through the operation of the Spirit; both of which are freely provided for every descendent of Adam.

V. OF CHRIST

Section I—Jesus Christ, the Son of God, possesses all divine perfections. As He and the Father are one, He in His divine nature, filled all the offices and performed the works of God to His creatures that have been the subjects of revelations to us. As man, He performed all the duties toward God that we are required to perform, repentance of sin excepted.

His divinity is proved from His titles, His attributes, and His works.

1. His Titles. The Bible ascribes to Christ the titles of Savior, Jehovah, Lord of Hosts, the first and the last, God, true God, great God, God over all, mighty God, and the everlasting Father.

2. Hic Attributes. He is eternal, unchangeable, omnipresent, omniscient, omnipotent, holy, and is to be worshiped.

3. His Works. By Christ the world was created, He preserves and governs it; He has provided redemption for all men and He will be their final Judge.

Section II—The Incarnation of Christ. The Word, which in the beginning was with God and which was God, by whom all things were made, condescended to a state of humiliation in being united with human nature and becoming like us, pollution and sin excepted. In this state, as a subject of the law, He was liable to the infirmities of our nature; was tempted as we are, but lived our example, perfect obedience to the divine requirements. As Christ was made of the seed of David according to the flesh, He is "the Son of Man"; and as the divine existence is the

fountain from which he proceeded, and was the only agency by which He was begotten, He is "the Son of God," being the only begotten of the Father, and the only incarnation of the Divine Being.

VI. THE ATONEMENT AND MEDIATION OF CHRIST

1. The Atonement. As sin cannot be pardoned without a sacrifice, and the blood of beasts could never wash away sin, Christ gave Himself a sacrifice for the sins of the world, and thus made salvation possible for all men. He died for us, suffering in our stead, to make known the righteousness of God, that He might be just in justifying sinners who believe in His Son. Through the redemption effected by Christ, salvation is actually enjoyed in this world, and will be enjoyed in the next by all who do not in this life refuse obedience to the known requirements of God. The atonement for sin was necessary. For present and future obedience can no more blot out our past sins than past obedience can remove the guilt of present and future sins. If God pardoned the sins of men without satisfaction for the violation of His law, it would follow that transgression might no on with impunity; government would be abrogated, and the obligation of obedience to God would be, in effect, removed.

2. Mediation of Christ. Our Lord not only died for our sins, but He arose for our justification, and ascended up to heaven, where, as the only Mediator between God and man, He makes intercession for us, until He comes again.

We believe that all children dying in infancy, having not actually transgressed against the law of God, in their own persons are only subject to the first death, which was brought on by the fall of the first Adam, and not that any one of them dying in that state shall suffer punishment in hell by the guilt of Adam's sin for of such is the Kingdom of God.

VII. THE HOLY SPIRIT

1. The Scriptures ascribe to the Holy Spirit the acts and attributes of an intelligent being. He guides, knows, moves, gives information, commands, forbids, sends forth, reproves, and can be sinned against.

2. The attributes of God are ascribed to the Holy Spirit.

3. The works of God are ascribed to the Holy Spirit; creation, inspiration, giving of life, and sanctification.

The apostles assert that the Holy Spirit is Lord and God. 4.

From the foregoing the conclusion is that the Holy Spirit is in reality God, and one with the Father in all divine perfections. It has also been shown that Jesus Christ is God—one with the Father. Then these three: the Father, Son, and Holy Spirit, are one God.

The truth of this doctrine is also proved from the fact that the Father, the Son, and the Holy Ghost are united in the authority by which believers are baptized; and in the benedictions pronounced by the apostles, which are acts of the highest religious worship.

VIII. THE GOSPEL CALL

The call of the Gospel is co-extensive with the atonement to all men, both by the word and strivings of the Spirit, so that salvation is rendered equally possible to all; and, if any fail of eternal life, the fault is wholly his own.

IX. REPENTANCE

The repentance which the Gospel requires includes a deep conviction, a penitential sorrow, an open confession, a decided hatred and an entire forsaking of all sin. This repentance God has enjoined on all men; and without it in this life the sinner must perish eternally.

X. FAITH

Saving faith is an assent of the mind to the fundamental truths of revelation, an acceptance of the Gospel, through the influence of the Holy Spirit; and a firm confidence and trust in Christ. The fruit of faith is obedience to the Gospel. The power to believe is the gift of God, but believing is an act of the creature, which is required as a condition of pardon and without which the sinner cannot obtain salvation. All men are required to believe in Christ; and those who yield obedience to this requirement become the children of God by faith.

XI. REGENERATION

As man is a fallen and sinful being, he must be regenerated, in order to obtain salvation. This change is an instantaneous renewal of the heart by the Holy Spirit, whereby the penitent sinner receives new life, becomes a child of God, and is disposed to serve Him. This is called in Scripture being born again — born of the Spirit, being quickened, passing from death unto life, and a partaking of the divine nature.

XII. JUSTIFICATION AND SANCTIFICATION

1. Justification. Personal justification implies that the person justified has been guilty before God and, in consideration of the atonement of Christ, accepted by faith, the sinner is pardoned and absolved from the guilt of sin and restored to the divine favor. Christ's atonement is the foundation of the sinner's redemption, yet, without repentance and faith, it can never give him justification and peace with God.

2. Sanctification. Sanctification is the continuing of God's grace by which the Christian may constantly grow in grace and in the knowledge of our Lord Jesus Christ.

XIII. PERSEVERENCE OF THE SAINTS

There are strong grounds to hope that the truly regenerate will persevere unto the end, and be saved, through the power of divine grace which is pledged for their support; but their future obedience and final salvation are neither determined nor certain, since through infirmity and manifold temptations they are in danger of falling; and they ought therefore to watch and pray, lest they make shipwreck of their faith and be lost.

XIV. THE SABBATH

This is one day in seven, which from the creation of the world God has set apart for sacred rest and holy service. Under the former dispensation the seventh day of the week as commemorative of the work of creation, was set apart for the Sabbath. Under the Gospel, the first day of the week, in commemoration of the resurrection of Christ, and by authority of Christ and the apostles, is observed as the Christian Sabbath. On this day all men are required to refrain from secular labor and devote themselves to the worship and service of God.

XV. THE CHURCH

A Christian Church is an organized body of believers in Christ,

who statedly assemble to worship God, and who sustain the ordinances of the Gospel according to the Scriptures. Believers in Christ are admitted to this church on giving evidence of faith in Christ, obtaining consent of the body, being baptized, and receiving the right hand of fellowship.

The Church of God, or members of the body of Christ, is the whole body of Christians throughout the whole world, and none but the regenerate are its members.

XVI. TITHING

Both the Old and New Scriptures teach Tithing as God's financial plan for the support of His work.

XVII. THE GOSPEL MINISTRY

1. Qualification of Ministers. They must possess good, natural and acquired abilities, deep and ardent piety, be especially called of God to the work and ordained by prayer and the laying on of hands.

2. Duties of Ministers. These are to preach the Word, administer the ordinances of the Gospel, visit their people, and otherwise perform the work of faithful ministers.

XVIII. ORDINANCES OF THE GOSPEL

1. Christian Baptism. This is the immersion of believers in water, in the name of the Father, the Son, and the Holy Spirit, in which are represented the burial and resurrection of Christ, the death of Christians to the world, the washing of their souls from the pollution of sin, their rising to newness of life, their engagement to serve God, and their resurrection at the last day.

2. The Lord's Supper. This is a commemoration of the death of Christ for our sins, in the use of bread which He made the emblem of His broken body, and the cup, the emblem of His shed blood, and by it the believer expresses his love for Christ, his faith and hope in Him, and pledges to Him perpetual fidelity.

It is the privilege and duty of all who have spiritual union with Christ to commemorate His death; and no man has a right to forbid these tokens to the least of His disciples.

3. Washing the Saints Feet. This is a sacred ordinance, which teaches humility, and reminds the believer of the necessity of a daily cleansing from all sin. It was instituted by the Lord Jesus Christ, and called an "example" on the night of His betrayal, and in connection with the institution of the Lord's Supper. It is the duty and happy prerogative of every believer to observe this sacred ordinance.

XIX. DEATH

1. Death. As a result of sin, all mankind, is subject to the death of the body. The soul does not die with the body; but immediately after

death enters into a conscious state of happiness or misery, according to the character here possessed.

XX. SECOND COMING OF CHRIST

The Lord Jesus, who ascended on high, and sits at the right hand of God, will come again, to close the Gospel dispensation, glorify His saints, and judge the world.

XXI. THE RESURRECTION

The Scriptures teach the resurrection of the bodies of all men, each in its own order; they that have done good will come forth to the resurrection of life, and they that have done evil to the resurrection of damnation.

XXII. THE JUDGMENT AND RETRIBUTION

1. The Judgment. There will be a judgment, when time and man's probation will close forever. Then all men will be judged according to their works.

2. Retribution. Immediately after the judgment, the righteous will enter into eternal life, and the wicked will go into a state of endless punishment.

RULES OF DECORUM

1. The Association, when convened, shall be opened and closed by singing and prayer.

2. Only one person shall speak at a time, who shall arise to his feet and address the Moderator.

3. Each person thus speaking shall not be interrupted in speech, except by the Moderator, until he gets through; nor shall the Moderator interrupt him unless he breaks order.

4. The person speaking shall adhere to the question and shall in no wise cast reflections on any person who may have spoken before him.

5. No person shall speak more than three times on the same subject without leave of the Association.

6. No person shall laugh or whisper in time of public speech.

7. Members shall address each other by the appellation of Brother or Brethren and Sisters.

8. No member of this Association shall absent himself when the Association is sitting in conference without leave of the Moderator.

9. The names of members of this Association shall be enrolled and called over as often as the Association thinks it necessary.

10. No member shall speak longer than fifteen minutes at any time without leave of the Moderator.

CHURCH COVENANT

Having given ourselves to God by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearances of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages and to "provide things honest in the sight of all men." We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions and social worship; and by self-denial, faith and good works, endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ." We will not forsake the assembling of ourselves together for church conferences, public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor and all its benevolent work. We agree to accept Christian admonition and reproof with meekness and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation and seek to strengthen the weak, encourage the afflicted, admonish the erring and, so far as we are able, promote the success of the church and of the Gospel. We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denomination enterprises, the support of Missions, the success of Sunday Schools and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.
