Proceedings

THE FIFTIETH ANNUAL SESSION OF THE ZION HOPE NO. 2 A S S O C I A T I O N ASSEMBLED AT THE CAMP GROUNDS, FIVE MILES NORTH AND THREE MILES WEST OF ALMA, THURSDAY NIGHT, SEPT. 17, 1964, TO BEGIN ITS TWO DAYS AND NIGHTS YEARLY CONFERENCE.

#### THURSDAY NIGHT SESSION

The session was opened by the singing of a hymn. Prayer by Bro. Elmer Coleman. The Moderator, Bro. Glenn Dipboye, called upon the Assistant Clerk, Mrs. Fred Smith, and Mrs. Ellen Bonewell to take their places at the Clerk's table. Sis. Bonewell was appointed by the Moderator to take the position of the late Clerk, Bro. Fred Smith, who departed this life a few days before this session convened. Prayer by Bro. Burl Osborne. A collection of \$17.20 was taken for the Association treasury.

The Introductory Message was delivered by Bro. Albert Rozell. He read the first eight verses of the first chapter of Job and titled his message, "The Trouble Maker." It was well delivered and well received as it was so fitting for the occasion.

Immediately following the message, the business session was opened by prayer. Seventeen letters were read, received, and delegates seated. Bro. Glenn Dipboye was re-elected Moderator to preside over this session. Bro. Wayne Bonewell was elected Clerk. Sis. Ellen Bonewell was elected Assistant Clerk, and Sis.

Fred Smith was elected to help them.

Motion carried that we adjourn and meet back at 9:30 Friday morning. Dismissed by prayer.

#### FRIDAY MORNING SESSION

Opened with singing. The Moderator requested that Bro. Everett Smith lead the hymns. Sis. Dorothy Bennett was seated at the piano. The song titles were "Trust and Obey," and "Yield Not to Temptation."

Scripture reading by Rev. Doyle Dipboye of the Eureka Association. He read from the third chapter of John. Prayer by Assistant Moderator, S. A. Smith. Rev. and Mrs. Doyle Dipboye and Rev. Lloyd Summerhill were seated as visitors. The Moderator recognized Rev. Dipboye and Rev. Summerhill, who made short talks of greeting. Both are former members of this Association. A Divine Service Committee was appointed by the Moderator. See Committees. Corresponding delegates from the Eureka Association were seated. They were: Sis. Otho Williams, Sis. Beulah Cordle, Sis. Zelma Briggance, and Sis. Herman Doss.

#### 11:00 O'CLOCK PREACHING SERVICE

Opened by singing, "Where the Soul Never Dies," and "The Old Ship of Zion." This was followed by an altar prayer. Preaching was by Rev. Lloyd Summerhill and Rev. Boyd Stout. The Scriptures chosen were Luke 12:24, and Romans 12. Two good messages were delivered, and a good spirit prevailed.

Lunch was served at the Camp Ground. Bro. Glenn Dipboye asked the Lord's blessing on the food, at the request of Sis. Bonewell. The ladies served a wonderful meal.

#### AFTERNOON SESSION

The body met back at 1:30 and opened by singing some good songs. The Moderator read Matt. 5:10-16. Prayer by Bro. Burl Osborne. The opening song was led by Bro. Everett Smith, with Sis. Dorothy Bennett at the piano.

The Moderator urged all of those present to start in now to try and get more ministers and more delegates to attend all of the next conference, so that the devil would have less opportunity to creep into our Association, and it would not be necessary to double back on the churches present for committee members. Also, by having more delegates and ministers present, we would not have to put off business that needed to be taken care of that day. The following committees were appointed:

2. Obituary Committee.

3. Sunday School Committee.

A partial report of Arrangements Committee was read and adopted. See Reports.

#### AFTERNOON PREACHING SERVICE

Congregation sung, "The Promised Land." Special by Christine Rand. Bro. Doyle Dipboye and Bro. Burl Osborne brought the messages, using Scriptures from Proverbs 15. The Theme was "Take Up Thy Cross and Follow Me." Both messages were good.

The business session adjourned, to meet back at 9:30 Saturday morning.

#### FRIDAY NIGHT SERVICE

The congregational singing was good. There were also some good specials sung. These were followed by an altar prayer. Rev. Everett Smith delivered the message, using St. John 13 and other Scriptures suited to the occasion. He delivered a good message. The Moderatór requested that Bro. Smith supervise the preparation for the Lord's Supper and Feet Washing. There was much shouting and rejoicing during the feet washing. A spiritual testimony service was conducted, and we enjoyed a good time in the Lord.

An offering of \$14.68 was taken for the Association treasury. Although the delegation was not so large as usual, there was a good spirit and unity so far in the conference. Dismissed by prayer.

#### SATURDAY MORNING SERVICE

Opened with singing. Rules of Order were read by the Moderator. Scripture reading was by the Ass't Moderator, S. A. Smith, followed by prayer. The Moderator, Bro. Dipboye, surrendered the chair to the Ass't. Moderator and proceeded to read the Treasurer's report. The report was received, and Bro. Dipboye was re-elected unanimously as Treasurer for the coming year. The report of the Association Evangelist was also read and received. Bro. Dipboye was re-elected as Evangelist and contact man for the coming year.

Bro. Joslin and Bro. Warner, who were to preach the

Memorial Sermon at 11:00 o'clock were absent. The body elected Bro. S. A. Smith and Bro. J. H. C. Jordan to deliver the messages.

A unanimous vote was given to centralize the Annual Conference of the Association at the Camp Grounds. It was also voted to centralize the Quarterly Conference (Fifth Sunday) provided no church asked for it by letter.

Bro. Burl Osborne was selected to preach the Introductory Sermon at the next meeting. Bro. Ben Storey, Jr. was chosen as alternate. Bro. Raymond Chronister and Bro. Robert Satterfield were selected to preach the Memorial Service.

Both Central Church and South Fort Smith Church will sponsor the meals for the next session. It is understood that each one will help them by bringing a covered dish or two.

It was voted that the Preachers and Deacons' Meeting be held at the Camp Grounds unless they chose to meet elsewhere.

#### 11:00 O'CLOCK PREACHING SERVICE

Bro. S. A. Smith, Assistant Moderator, took charge of the service. Bro. Bonewell read the names of the deceased. Prayer by Bro. Bill Dillon. Bro. S. A. Smith preached first, using Rev. 1:3-14 as his text. He was followed by Bro. J. H. C. Jordan, and both delivered excellent messages. The Moderator made a short talk about the deceased, and this was followed by a song and handshake. People were spiritually moved, and a good spirit prevailed. A dismissal prayer was offered. The Lord's blessing on the food was asked at this time also.

#### SATURDAY AFTERNOON SERVICE

After enjoying a bountiful meal, the body met back in session to conduct business. Scripture reading was by the Moderator, from Matt. 17:1-6. Prayer by the Assistant Moderator, Bro. S. A. Smith. Bro. Everett Smith was elected for a threeyear term on the Ordaining Council. Bro. Robert Satterfield was elected for a five-year term on the Executive Board. He succeeds Bro. Earl Christian.

The Moderator, who is also Treasurer, stated that the body should elect delegates to the State Association. He stated that it was his belief there was not enough money in the treasury to pay their way, and that some money should be sent to the State Conference. He stated that we did not have enough to send all that they wanted this year—nor last year. It was his belief that we would have to send what the treasury could afford after taking care of our Associational expenses. No other suggestions were made, and that is the way it was left. Bro. Everett Smith said he planned to go to the State Conference, if possible. Bro. S. A. Smith said he could go with Bro. Everett Smith. Others elected to go with them as delegates were: Sis. Edna Smith, Sis. Billie Smith, and Sis. Vi Smith.

Final reports of the following committees were read and the committees discharged: Arrangements Committee, Pulpit Committee, Sunday School Committee, and Obituary Committee.

The Standing Committees' reports were received, without discharging the committees. See "Committees," and "Reports."

Sis. Ellen Bonewell was unanimously elected as Reporter to "The Vision," our state paper. The body voted for the young people to have services at the Camp Grounds the first Saturday night of every month, starting in October. Bro. Everett Smith was selected to be sponsor. He is to be assisted by Bro. Burl Osborne.

A collection of \$46.00 was taken for Bro. Woody, who was in the hospital at that time.

#### AFTERNOON PREACHING SERVICE

Bro. Raymond Chronister preached, using Nehemiah 1:6. His theme was "The Walls Are Torn Down." He was followed by Bro. Ben Storey, Jr., who used Genesis 32:27-28. His theme was "Sold Out to the Devil." Both messages were forcefully delivered. A good spirit and unity continued throughout the session.

All eighteen churches represented by letter. The body then voted to adjourn until the next session, which will meet at the Camp Grounds on Thursday night before the First Sunday in September, 1965. It was agreed to dismiss with an altar prayer, and to also pray for Bro. Woody and other sick.

#### RULES OF ORDER

#### Zion Hope No. 2 Association of Free Will Baptists

Article 1. At every sitting business shall be opened and concluded by prayer by the Moderator or whosoever he may call on.

Article 2. Visiting ministers and members from other conferences or Associations are to be received as visitors and welcomed to worship with us, but do not have the right to vote.

Article 3. Those allowed to vote are the standing delegates of the Association which are ordained ministers, ordained deacons, and church clerks of this Association, also the 5 delegates from each church after they have been seated by the standing delegates.

Article 4. Those who speak shall arise and address the Moderator, personal reflections shall be avoided in all discussions.

Article 5. No motion shall be discussed without first being seconded.

Article 6. When a motion has been made and seconded and a member opposes its discussion, the Moderator shall put the question, shall it be discussed? If negative the question shall be dismissed.

Article 7. If any proposition or motion under discussion contains 2 or more points, it shall be divided at the request of any member and the vote be taken separately.

Article 8. Motions made and lost shall not be recorded. Article 9. No one shall speak more than twice on any subject without special leave of the Moderator.

Article 10. The Moderator shall have the authority to object to any discussion not carried on in a Christian spirit.

Article 11. All questions shall be decided by a majority of the members present except where a two-thirds majority is required as mentioned in the Constitution and By-Laws.

Article 12. No member shall absent himself or herself without special leave of the Moderator.

Article 13. Minutes shall be leisurely read and corrected before the close of the Association if necessary.

Article 14. The rules of order shall be distinctly read from the chair immediately after organization.

Article 15. At all sessions of the Association arrangements shall be made to insure such sermons as required or other devotional exercises equivalent thereto.

Article 16. Alterations may be made to these rules at any regular session of the Association providing the proper steps have been taken in presenting them before the body.

#### BY-LAWS OF ZION HOPE NO. 2 ASSOCIATION OF FREE WILL BAPTISTS

1. Our Association shall meet on Thursday night before the third Sunday in September, and it shall adjourn sometime Saturday p.m. The Quarterly (or fifth Sunday) Conference shall meet on Friday night before each fifth Sunday and close its business session Saturday p.m. The Quarterly Conference has Saturday night service, but the Association does not.

2. The letters are to be read and delegates seated on the opening night of the Association and Quarterly Conference. Tardy letters are to be read and received when presented.

3. Letters to the Yearly Association shall be mailed to the Clerk at least two weeks before the Association meets. Letters to the Quarterly Conference are to be presented on Friday night, or as soon as possible.

4. After the letters have been read and received on the opening night of the Association and Quarterly Meeting and delegates present are seated, a Moderator and Assistant Moderator, a Clerk and Assistant Clerk shall be elected on the opening night, after the message.

5. A ruling of the Moderator may be voted down by the required two-thirds majority.

6. No member shall be allowed to serve on more than one standing committee, and only one member from the same church shall be allowed to serve on the same standing committee.

7. We recommend that no preacher be selected to preach twice at the same session of the Association or Quarterly Conference, and that no preacher be selected to preach that is not present at the session at the time he is elected. This is to keep from discouraging or casting reflections on faithful ministers present.

8. Visiting ministers and members from other Conferences or Associations are to be received as visitors and welcomed to worship and be with us, but do not have the right to vote.

9. All official boards or committee members must be members of this Association.

10. The Treasurer shall be paid \$25.00 for managing the printing of the minutes and other duties added thereto. The Clerk and Assistant Clerk shall be paid \$10.00 each. This stands until changed.

11. The Treasurer is delegated to get the Association minutes to each church as soon as he can get them printed. He is delegated to write checks for printing and mailing expenses of our minutes and the State Association minutes, and other needs as voted by this Association, such as Ministers' Report Cards, License and Ordination Blanks, and he or the Clerk is to notify the State Association of this each year so the minutes can be distributed without too much delay.

12. All Standing Boards of this Association are to make a written report to the Yearly Association and also to the Quarterly Conference when necessary. Ministers shall give their written reports to the Yearly Association, and they shall in return receive Certificates of Good Standing, unless proved otherwise.

13. Any minister that does not have Free Will Baptist credentials shall be required to carry license for twelve months. After that period, if the Ordaining Council sees fit, they may recommend to the Conference or Association that he carry them longer. If he is not found to be of sound doctrine, the Council may recommend that he be not accepted. After either recommendation, a vote must be taken by the body.

14. As this Association has an elected Ordaining Council which is in accordance with the Treatise and National Associaation, be it resolved by this Association that it is the only Ordaining Council we have, and no minister shall henceforth accept papers without the names of this Ordaining Council being placed under the heading on the papers which says: "Names of Ordaining Council." It shall be the duty of the Ordaining Council to instruct a minister who is to be ordained, that he may have the choice of selecting the place where he is to be ordained, and that he may choose whom to ordain him-provided they be qualified, and their names may be placed on the papers if he wishes, though it is not essential, but the names of the Ordaining Council shall be placed under that heading after they have made sure that he has been ordained. This is a precaution that should benefit both the ministers and the Association, and prevent trouble that could arise. The Ordaining Council shall obtain that promise from the ordained and this Association will expect him to keep that promise, for the fact that he chooses three men to ordain him does not elect them to the Ordaining Council, and for them to sign as Ordaining Council could be confusing.

15. It is recommended that this Association try to have one preacher to preach Thursday night, two preachers for Friday morning, two for Friday afternoon, one to preach Friday night followed by Communion and Feet-washing, one to preach the Memorial Message Saturday morning at eleven o'clock, and two to preach Saturday afternoon. The Quarterly Conference shall elect two to preach on Friday night, two Saturday morning, two Saturday afternoon and one Saturday night to be followed by Communion and Feet-washing.

16. The ministers for the Introduction and Memorial Messages shall be chosen by the delegates at the session before. Should business become so pressing that the Moderator deems it necessary to postpone the afternoon service at any time, he may do so by a majority vote.

17. It is recommended that each church send thirteen dollars to the Association for its support.

18. It is recommended that an offering be taken on Thursday and Friday night to go to the Associational Treasury, for its support.

19. These Rules and By-Laws may be changed at any regular session of the Association by a majority vote of members present providing proper notice has been given as mentioned in the Constitution.

Amendment No. 1 to Article No. 14. Be it resolved that the ordination papers will be signed by the Ordaining Council and also that they will be signed by the Presbytery doing the ordaining each under its proper heading and that future certificates be printed to show the proper heading.

#### REVISED CONSTITUTION OF ZION HOPE NO. 2 ASSOCIATION ADOPTED SEPTEMBER 14, 1963

PREAMBLE: From long experience, the Church of God Denominated Free Will Baptists, being regularly baptized upon profession of our faith in our Lord and Saviour Jesus Christ, and being convinced of the necessity of a combination of churches to perpetuate a union among us and to preserve and maintain correspondence with each other, do therefore ordain this Constitution for our better associational government.

#### ARTICLE I

NAME: This Association shall be named or denominated ZION HOPE NO. 2 ASSOCIATION OF FREE WILL BAP-TISTS. It shall be composed of sundry churches located mainly in the state of Arkansas, but including churches from other states which come to us by petitionary letters, for convenience and other important reasons. This Association is to have no power to usurp authority over "Lord it over" God's heritage, nor to have any ecclesiastical power over the churches which compose this Association. It reserves the right to deal with or revoke the credentials of ministers, both licensed and ordained who are members of churches which compose this Association providing, however, that we have a good Bible reason and proceed in accordance with the doctrines and practices of the Free Will Baptists.

#### ARTICLE II

COMPOSITION: This Association shall be composed of members chosen by the different churches of our union, not exceeding 5 delegates from each church. Absentee delegates from a church may be replaced by other members of said church that are present—or alternate delegates may be sent by the

churches to fill any vacancy that should arise. Upon producing letters, these delegates shall be entitled to seats. Churches may be represented by statement if no letter or delegates are present. They shall be seated by a vote of the standing delegates. Ordained ministers, ordained deacons and church clerks of said union shall be consider regular standing delegates (or members) when present, by virtue of their office.

#### ARTICLE III

Churches who are members of this Association are requested to send their ministers to this Association or Quarterly Conference to be examined for a license or ordination. They shall be examined by the Ordaining Council, which shall be elected by the Association. After examination the Ordaining Council make a recommendation which is received or rejected by a vote of the associational body. In harmony with the treatise of the National Association, if a minister is found unworthy or unsound, the Association may order the Ordaining Council to annul his credentials, providing the Association has carried out the Biblical procedure, which is accepted by the denomination as a whole. This procedure is not contrary to congregational government, as this has been in general practice among Free Will Baptists for many years. Neither is it an act of ecclesiastical power over the churches—as the voting body is composed of representative members from the various churches comprising this associational body.

#### ARTICLE IV

In case this Association has an elected office, a contact man to work for and among the churches of this Association such as an evangelist, home missionary, promotional field worker, or any office they choose to elect and this office has been of continued practice for a period of time, be it hereby affirmed that in order to present a proposal of discontinuance and a vote taken at a time when the delegation is small, some churches not represented and others taken by surprise and unable to fairly represent their churches which might cause confusion, be it understood that no such question or proposal shall be considered by this Association until it has first been mentioned at a Quarterly Conference and the Clerk instructed to notify each church in the Association at least three months before the Yearly Association where the question shall then be taken into consideration and the vote taken.

#### ARTICLE V

Letters from the different churches represented at an Associational meeting shall contain the following: (1) the number of members in fellowship; (2) the names and addresses of their 24 pastor, clerk, ordained ministers and deacons, licensed ministers and deacons; (3) the number of members received (by profession of faith, by letter or recommendation or by statement) which shall include restoration of denominational choice or whatever might be the cause; (4) the number of members dismissed; (5) the number and names of members deceased since the last general session of the Association. The churches may also send an obituary of the deceased; (6) also the financial record of their church.

#### ARTICLE VI

Newly constituted churches wishing admission to the Association shall send a petitioning letter and delegates to the Associational meeting. If upon examination, they are found to be orthodox and orderly they may be received into the Association by a majority vote of the body. The Moderator may then extend the right hand of fellowship to the delegates of the new church, but it is not to be considered essential to membership. Churches wishing to come into this Association from other Free Will Baptist Associations shall present a letter of recommendation from the Association which they are leaving. If a church from an Association which has failed to meet in session for a period of over twelve months and has become inactive, wishes to come into this Association, they may present a petitionary letter-stating the reason for their desire to join this Association. If approved, after examination they may be received into this body. A church wishing to come into this Association from another denomination must first be organized into a Free Will Baptist Church. It shall be examined by standing official members of this Association, and after organization, it may ask for membership into this body. If it is found to be

orthodox and orderly, it shall then be received.

#### ARTICLE VII

This Association shall consider every action which has been made and seconded—unless it be withdrawn by the members who made and seconded it. No motion shall be discussed until it has received a second. If no second is forthcoming, it shall be considered dead.

#### ARTICLE VIII

This Association shall endeavor to furnish the member churches with minutes of the Association in proportion to the membership of each church—the distribution to be at the discretion of the Association.

#### ARTICLE IX

The minutes of the Association shall be read and corrected, if necessary. They shall be then received by the body and duly signed by the Moderator and Clerk.

#### ARTICLE X

It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book (or books) which shall be kept by the Association as a record.

#### ARTICLE XI

The Standing Committees of this Association shall be an Ordaining Council, Executive Board and any other which may be considered necessary for the efficient handling of associational business. These shall serve throughout the entire year. The Association may have committees to serve for one session such as: Sunday School; Obituary; Arrangements; Divine Service; Finance, or others as deemed necessary. These committees may be either appointed by the Moderator or elected by the associational body. A Chairman for each Standing Committee may be appointed or selected at the Association to serve until the committee can meet and make its own selection. The Ordaining Council shall consist of 3 members and the Executive Board shall have 5 members, one elected each year.

#### ARTICLE XII

The duties of the Executive Board shall be to act in behalf of and for the Zion Hope No. 2 Association on emergency matters which arise when the body is not in session—To be responsible for all legal matters that might come to the attention of the body—To hold in trust and supervise all properties that belong to, or have been purchased by this Association, unless otherwise ordered by the body—To discharge any other duties which the body might see fit to place upon it.

#### ARTICLE XIII

In emergency matters, the Moderator may, with the consent of the Executive Board call a special session of the Association. However, each church in the Association must be notified at least thirty days in advance of said special session.

#### ARTICLE XIV

All questions shall be settled by a majority vote of the members present, except where otherwise mentioned in the Constitution, Rules and By-Laws which require a two-thirds majority.

#### ARTICLE XV

In event that any changes are to be made in this Constitution, Rules or By-Laws, they shall first be presented at the Quarterly Conference prior to the Association unless a special session is called and the Clerk shall be instructed to notify

the churches of the impending action so that it can be properly constituted and then brought to the Association to be acted upon.

#### ARTICLE XVI

This Constitution may be changed or amended at any regular session of the Association by a two-thirds majority vote of members present, providing proper notice has been given as mentioned in Article XV, in no case shall it be changed or amended with less than a two-thirds majority.

#### RULES OF ORDINATION

1. Do you believe in the total depravity of the human heart? Answer: No.

2. Do you believe that infants are saved while in a state of innocence? Answer: I do.

3. Do you believe in a full and free salvation to all who will accept it on the gospel terms? Answer: I do.

4. Do you believe in a burial of a believer in Christ with water after he has been baptized into Christ by the Holy Ghost is the only baptism? Answer: I do.

5. Do you believe that any man has a right in the gospel to repeat baptism to such a subject? Answer: No.

6. Do you believe that communion, feet washing and baptism are gospel ordinances and are to be taught and practiced until He comes again? Answer: I do.

7. Will you solemnly pledge yourself to preach and practice the same, God being your helper? Answer: I will by the help of God.

8. Do you believe that none will be finally saved but those who persevere in holiness to the end? Answer: I do.

#### ARTICLES OF FAITH

1. We believe in one true and living God, the Father, Son and Holy Ghost, and these three are equal in divine essence, power and glory (Romans 1:20; I John 1:7; John 17:21).

2. We believe that the Scriptures of the Old and New Testaments are the written Word of God, and are the only infallible rule of faith and practice (Matthew 5:18; II Timothy 3:16).

3. We believe that God created man good and gave him holy commandments whereby he should live holy, but man voluntarily disobeyed the commandments of God, transgressed the law and fell under the just condemnation of the same whereby all mankind are sinners; not by constraint, but by

choice, being partakers of the sinful nature attained by the fall. That man is unable to save himself with his own power, but we see Jesus for the suffering of death crowned by glory, that He, by the grace of God, should taste death for every man (Genesis 3:7-17; Hebrews 2:9).

4. We believe that Christ, by His death, burial and resurrection, purchased our pardon and offered it freely to all mankind upon the principles of repentance toward God and faith in the Lord Jesus Christ. He now commands all men everywhere to repent, therefore He saith: "Look unto me, and be ye saved, all the ends of the earth: for I am God, and there is none else" (Matthew 4:17; Isaiah 45:22; Acts 20:2-21; Acts 17:30).

5. We believe that adult persons must be regenerated and born of the Spirit of God if they inherit eternal life (John 3:3).

6. We believe that infants and idiots are saved by the merits of the Son of God (John 4:11; Deuteronomy 1:39; Mark 10:14; Luke 18:16).

7. We believe that all Christians should persevere in grace and be faithful to the end if they inherit eternal life; for blessed are they that do His commandments that they may have right to the tree of life, and may enter in through the gates of the city (Matthew 24:13; Revelation 22:14).

8. We believe that baptism by immersion is the apostolic mode, even the burial of the believer in water; and that Christ, who is our life, showed this humble example to His children and bids us walk therein (John 3:22; Matthew 3:16; 28:19; Romans 6:2-5).

9. We believe that God in His goodness displays His power of grace in a great degree in calling and qualifying His servant by the teaching of the Holy Ghost, and by the instructions of His blessed Word, to go forth and proclaim life and salvation. He bids us freely to come, and nothing prevents the salvation of any but their own stubborn rebellion and sinful refusal to come (I Corinthians 12:13; Ephesians 3:7; Revelation 22:17; Isaiah 55:1).

10. We believe that baptism, the Lord's Supper and washing the saints' feet are divine ordinances and should be observed by all His children (Mark 14:22; John 13:4-14; Matthew 28:19, 20; I Timothy 5:10).

11. We believe that none have a right to baptism only those who have obtained a living hope in the Lord Jesus Christ and none have the right to administer the same, only those who are called of God and have come under the hands of the 28 Presbytery of elders. Each church ought to have a pastor, deacons and clerk, chosen by the church and to continue in office during the good pleasure of the same. In dealing with disorderly members, reference should be had in the 18th chapter of Matthew and other Scriptures relative to dealing with disorderly members. In all cases a majority shall rule, except in receiving members which shall be unanimous (Titus 1:5; Acts 14:23; II Corinthians 6:6).

12. We believe it to be the duty of each church to assemble themselves together once a month and that it is the duty of the pastor of the church, when setting forth the Lord's Supper, to ... "let a man examine himself, and so let him eat, ..." (I Corinthians 11:28; John 13:14; Hebrews 10:25).

13. We believe that sanctification and holiness is a Bible doctrine; that immortality is God dwelling in the light so when this corruptible shall have put on incorruption and this mortal shall have put on immortality, then shall be brought to pass the saying that is written, "Death is swallowed up in victory." We believe it is our duty to be tender and affectionate to one another, study the happiness of the people of God in general and to be singly engaged to promote the honor and glory of God (Galatians 6:10; I John 2:9).

14. We believe in the resurrection of the dead, both the just and the unjust. The resurrection of the just to glory and immortality in the presence of God, the unjust to everlasting shame and banishment from the presence of God (Matthew 25:31, 34; I Corinthians 15:45; II Thessalonians 1:4, 11; Revelation 20:12, 15).

#### CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise, by His grace, to love and obey Him in all things, to avoid all appearances of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions and social worship; and by self-denial, faith and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences, public worship and the observance of the ordinances of the gospel; nor fail to pay according to our ability for the support of the church, of its poor and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace. To be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
