MINISTERS' REPORTS

Report of Rev. J. T. Quick, Rt. 1, Richton, Miss.: Greetings in the Lord to the Zion Rest Free Will Baptist Association.

I humbly submit the following report of my years work ending September 25, 1955. Number of miles traveled 5,614; number of churches pastored 2, half time for each church; Churches organized one; members received 14; Baptized 6; no funerals conducted, held one revival; received for pastoral work \$1,480.16. Received miscellaneous \$166.38, grand total received \$1,646.54. Sermons preached 120, traveling expenses \$130.00.

Report of Rev. Cecil Walley, Rt. 1, Richton, Miss.: Greetings in the name of the Lord to the Zion Rest Association of the Free Will Baptists. I present the following report of my year's work ending Sept. 18, 1955. No. of miles traveled about 300; churches pastored one; members received 19, Baptized 21; money received \$126.16, sermons preached 35.

Report of Rev. Tillis Walley, Rt. 1, Richton, Miss. Greetings in the name of the Lord to the Zion Rest Association of the Free Will Baptists. Please accept my report as follows: I have preached 16 sermons, had four conversions, 3 reclaimed and Baptized 2. Traveled 416 miles.

The Moderator welcomed Bro. Kyrless Walley as a visiting minister. Next the Moderator appointed a devotional committee, Bro. Jim

Walley, Bro. Frank Henderson, Bro. B. O. McLain. Then the Moderator called for a move and second that each minister have a certificate of standing. Next moved and seconded that we insert on the church letters how much each church pays in for Home Mission funds each year.

2. We suggest that the association meet with Corinth Church in 1956.

3. We suggest that the quarterly meeting meet with New Love Well Church in October, and that the second quarterly meeting meet with Bethel Church, the third quarterly meeting meet with County Line and the fourth with Lees Chapel.

4. We suggest that the By-Laws of the tent be put in the minutes.

5. We suggest that the delegated body elect the preacher to preach the introductory sermon next year in the Association. Rev. Joe Conway was elected to preach the sermon at Corinth in 1956.

Rules and By-Laws concerning the Tent:

1. Resolved that no minister shall use the Tent who opposes Free Will Baptist doctorine.

2. Resolved that any minister, who is in good standing with the Zion Rest Association of Free Will Baptist Faith is entitled to use the Tent.

3. Resolved that the tent shall not be used other than Religious purposes and all churches shall be entitled to the use of the tent when it is not in use, or has already been spoken for. Churches may use the tent by making request to the person in charge of it.

4. Resolved that no minister shall be allowed to use the tent without permission of the Home Mission board and under their direction.

5. Resolved that a copy of these rules be posted in each church for their information.

6. Resolved that these rules shall not be altered, amended or changed except by a two-thirds majority of Home Mission Board present.

At this time the Moderator appointed Bro. Lonnie Walley as Sunday School Evangelist for the following year of 1956. Bro. Lonnie will contact the different churches and fix the visiting dates later.

CONSTITUTION

Article 1. This Association shall be known as the Zion Rest Free Will Baptist Association of Mississippi, and be composed of delegates from churches composing same. Each church shall be entitled to two delegates to represent her at each session.

Article 2. This body shall be considered an advisory council, but having no authority over local affairs of the church.

Article 3. Each church of this body shall be considered an independent body, and shall control her own affairs in matters of discipline, etc. She may, however, in extreme cases, call in aid from sister churches.

Article 4. All questions of doctrine and matters of general interest shall be settled by two-thirds vote of the Association, and this vote shall be final.

Article 5. The officers of this Association shall be a moderator, assistant moderator and treasurer, who shall be chosen by a majority vote annually.

Article 6. This Association shall meet at such time and place as shall be most convenient and shall not adjourn finally until all business is transacted.

Article 7. Churches wishing to become members of this Association must adopt the Articles of Faith and conform to its useage. We agree as churches composing this Association, to use our best influence to promote the interest of all moral and benevolent institutions, such as Temperance Cause, Sunday Schools, Missions, and so on.

Article 8. Any person who feels that he is called to preach shall be recommended to the Quarterly meeting or association by the church to which he belongs to License him. Then, if he is found worthy of Ordaination, his church shall recommend him to the Quarterly Meeting or association for Ordaination.

Article 9. This Constitution shall be amended at any regular session by two-thirds vote of the members present, provided the change is recommended in writing on the day before the vote is to be taken.

RULES OF DECORUM

Article 1. This Association shall be called to order by the former moderator, who presided at the last session; the former clerk also officiates until the body is fully organized.

Article 2. The Moderator and Clerk shall be chosen by ballot at each session; a majority of members present elect.

Article 3. The names of delegates from the different churches

shall be enrolled and called as often as necessary during the session.

Article 4. A majority of delegates shall rule in all cases except in reception of churches into our body, which shall be unanimous.

Article 5. The moderator shall vote in case only when the Association is equally divided, but shall have equal right to speak on any question, provided he puts the assistant in the chair while he is speaking.

Article 6. Only one person shall speak at a time, who shall arise and address the monerator.

Article 7. No brother shall be interrupted while speaking unless he departs from the subject under discussion, or uses words of personal reflection.

Article 8. No person shall be allowed to speak more than fifteen minutes at a time, nor more than twice without the consent of the body.

Article 9. No member shall laugh or talk during the time the discussion is going on.

Article 10. No member shall absent himself from the Association while in session without leave of the moderator.

ARTICLES OF FAITH

1. The Bible, the Scriptures of the Old and New Testament, were given by inspiration of God, and are our infallible rule of faith and practice.

2. God. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe, and in the Scriptures as Father, Son, and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.

3. Christ. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The Mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Savior and Lord.

4. The Holy Spirit. The Scriptures assign to the Holy Spirit all the attributes of God.

5. The Government of God. God exercises a wise and benvolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.

6. The Sinfulness of Man. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty bfore God.

7. The Work of Christ. The Son of God by His incarnation, life, sufferings, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. The Terms of Salvation. The conditions of salvation are:

1. Repentence or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

9. Election. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect.

10. Freedom of the Will. The human will is free and selfcontrolled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. Preseverance. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

13. Gospel Ordinances. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel; feet washing, an ordinance teaching humility, of universal obligation, and to be ministered to all true believers.

14. Tithing. God commanded tithes and offerings in the old Testament; Jesus Christ endorsed it in the Gospel (Matt. 23-23),

and the Apostle Paul said, "Upon the first day of the week let everyone of you lay by him in store as God hath prospered him." (I. Cor. 16-2)

15. The Christian Sabbath. The Divine Law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works and activities, and for personal communications with God.

16. Resurrection, Judgment and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

CHURCH COVENANT

Having given ourselves to God, by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of

the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith and good works endeavor to "grow in the grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences; public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, or its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the church and of the Gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprise supreme; counting it our chief business in life to extend the influence of Christ in society constantly by praying and toiling that the Kingdom of God may come and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of Missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of Peace sanctify us wholly and preserve us blameless unto the coming of our Lord Jesus Christ.
