"Be Ye Filled

With The Spirit"

In Ephesians 5:18 the Apostle Paul admonishes us to be filled with the Spirit. In this day when so much emphasis is placed upon receiving the Holy Ghost, with the evidence being speaking in tongues, I wonder if we Free Will Baptists aren't somewhat confused. I wonder if we aren't almost afraid to preach being filled with the Spirit, because someone will think that we are advocating speaking in tongues. We should, however, see what the Bible has to say about this command in God's Word to be filled with the Spirit.

In Romans 8:9 we are told that if any man have not the Spirit of Christ he is none of His. In Titus 3:5 we are told that our sins are washed away and that we are saved by the regeneration of the Holy Ghost. I firmly believe the Bible teaches, and that Free Will Baptists believe, we receive the Holy Ghost when we are saved and that we can't be saved without the Holy Ghost. It is impossible to accept Christ without accepting God the Father and God the Holy Spirit. However, the Bible teaches that we are to be filled with the Spirit and that the disciples were filled with the Spirit more than one time.

Many people, when they begin to explore being filled with the Spirit, want to talk about their personal experience and about how they received the evidence that they were filled, that is, speaking in tongues. But, I am convinced from the study of God's Word that we should take what the Bible teaches instead of what someone has told us or someone's experience. God's Word is more accurate than a thousand experiences, because the Bible says that there is more than one spirit in this world and that we are to try the spirits. This means that we are to try them according to God's Holy Word and if they don't measure up, then believe the Word of God rather than an experience that someone has had. Let's see what the Word of God teaches concerning being filled with the Spirit and how that you shall know that you have been filled with the Spirit.

Let's begin first by looking at John 16:7-14

which tells us that the office and the work of the Holy Spirit will be to convince the world of sin, of righteousness, and of judgment, and that He (the Holy Spirit) will bear witness of Christ. In other words it is the job of the Holy Spirit to convict the heart of the sinner and bring him to Christ for salvation. Then, in Acts 1:8 we are told what the evidence would be, that the promise made by Jesus, was fulfilled. "But ye shall receive power, after that the Holy Ghost is come upon you; and ye shall be witnesses unto me both in Jerusalem, and in all Judaea, and in Samaria, and unto the uttermost part of the earth." There you have it! The Bible statement of what would happen to let the disciples know that the promise had been fulfilled. The would receive power to be a WITNESS OF CHR 1. Now, let's go to the second chapter of Acts and Lead verse 41 to see if this really came to pass. Did the disciples in fact receive power to be a witness for Christ? Yes! yes! yes! Three-thousand souls converted attest to the fact that they witnessed of Jesus Christ in the power of the Holy Ghost. You say, why preacher, I thought that they spoke in tongues as the evidence. No! that's not what the Bible says, it says in Acts 1:8, that they were to receive power to be a witness of Christ. The fact that they spoke in

understand their witness for Christ.

In Acts 4:31 the Bible speaks of another filling of the Holy Ghost that Peter and John received after they had been beaten and treated evil. Did they speak in tongues this time? The Bible says that this time there was an earthquake—that the ground trembled. Let me ask you this question. If the evidence of the filling of the Holy Ghost is speaking in tongues the first time you receive the Holy Ghost, then, should you expect an earthquake the second time you are filled with the Holy Ghost? Ridiculous, you say? Well, no more so than to insist that the evidence of the initial infilling is speaking in tongues. Let's not add something to God's Word.

Let's just accept what the Bible says is the evidence of the filling of the Holy Ghost, that is, the power to WITNESS OF AND FOR JESUS CHRIST.

You say, "Preacher, I don't have that power to witness, I'm afraid." Remember when you were first saved? Remember how that you wanted to tell people what had happened to you and how good you felt to be forgiven of your sin, that you were going to make Heaven and miss Hell? That was because the Holy Ghost had taken up residence in your life when you repented and accepted Christ. Since that time you may have become worldly and indifferent to the cause of Christ. You may have become disobedient to God and His Word in some portion of your life or service. If this is the case, you are not being led by the Spirit but by yourself. You are filled with self. Until you are willing to empty the vessel, it cannot be filled with the Spirit of God. You just can't fill something that is already full.

Just as one filling of the Spirit wasn't enough for the disciples, neither is it enough for you and me. We need to be filled with the Spirit daily and sometimes many times daily depending upon the task and the trial awaiting us. We are plainly commanded to be filled with the Spirit and to be led by the Spirit. We as Free Will Baptists must recognize the need and preach it from our pulpits if our people are to be the soul winners that we are commanded to be in Christ's Great Commission. Through prayer and communion with God, we will be able to receive the infilling of the Spirit that is needed. When we do receive the infilling of the Spirit we will be WITNESSES for Christ and SOUL WINNERS.

If you have never accepted Christ as your Savior, you will never be filled with the Spirit of God and will never win anyone to Christ. Won't you now bow your head, repent of your sins, and accept Christ as your Savior, then go out and win others to Christ?

A special place of interest was the Garden Tomb. The empty tomb gives a message loud and clear that "He Lives."







BIBLE IN SCHOOL OR PENITENTIARY?

The Bible was the chart and compass of the fathers of this Republic, and was the guiding star of the framers of our Constitution," editorialized the *Chicago Daily News*. "It never entered their minds to prohibit the reading of the Bible in schools. Yet the Supreme Court of Illinois, by a vote of five to two, has prohibited the reading of the Bible in the public schools in Illinois."

How paradoxical is this prohibition in reference to a provision of an Illinois prison law which stipulates: "It shall be the duty of chaplains to perform religious services in the penitentiaries; to attend to the spiritual wants of the convicts; to visit the convicts in their cells for the purpose of giving them moral and religious instruction and to furnish, at the expense of the State, a Bible to each convict"!

Would it not be sounder economy to furnish the schoolboy with a Bible before he reaches the penitentiary, rather than after he arrives there? Isn't it better to build safeguards at the top of the precipice rather than hospitals at its base?
